**SUBJECT: REINSTATING THE NAME OF JACUMBA HOT SPRINGS

The U.S. Board on Geographic Names is the designated body responsible for decisions regarding geographic names and their uniform usage within the Federal government and related agencies. The purpose of the U.S. Board on Geographic Names is to ensure the uniformity of all geographic names within all major federal agencies that deal with population, geographic information, ecology, and management of public lands. In order to maintain name conformity among federal agencies, the Board is responsible for the oversight of name inquiries, name changes, and new name proposals.

The unincorporated community of Jacumba, located in the Mountain Empire Subregion of the County of San Diego, has submitted a request to the U.S. Board on Geographic Names in order to reclaim its original name of Jacumba Hot Springs. The Jacumba Sponsor Group unanimously voted to support this change with no community opposition. The Board on Geographic Names has requested input from the Board of Supervisors prior to making a final decision on the name change.
